### North on the Harbor Freeway (110)

- Exit Exposition Boulevard
- Turn left to Flower Street
- Turn left on Flower to Figueroa Street
- Enter Exposition Park 1/2 block on the right (39th Street/Exposition Park Drive)
- Follow guest parking signs to the parking structure
